

**Objectives and investment policy**

**Objectives**

The objective of this fund is to achieve long-term investment growth, while applying a defensive-to-balanced asset allocation strategy. The share class is accumulating.

**Investment policy**

The fund gains exposure, directly or through other funds, to bonds and equities with emphasis on bonds. The fund mainly invests in underlying funds where similar ESG-related processes, criteria and characteristics are applied or can be found. The fund may gain exposure to any credit quality, sector and country, including emerging markets.

Specifically, the fund's default asset allocation is 80% in bonds and 20% in equities, and it is expected that such an allocation will not change significantly. The allocation to bonds and other debt securities shall be 75% to 85% and the allocation to equities 15% to 25%.

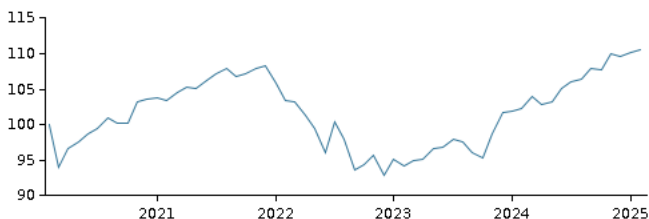
The fund is categorised as article 8 under SFDR and promotes environmental and/or social characteristics, as well as good governance practices, through screening, exclusions, investment analysis and decision-making as well as active ownership. The fund follows Danske Invest's responsible investment policy.

In actively managing the fund's portfolio, the management team uses an asset allocation based on a clearly defined investment process.

The fund may use derivatives for hedging and efficient portfolio management, as well as for investment purposes.

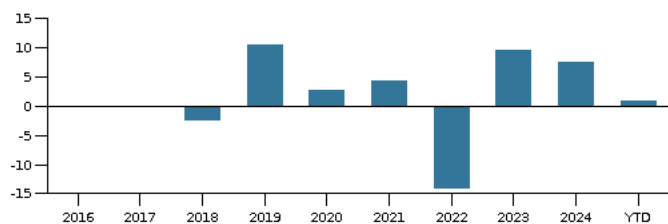
Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

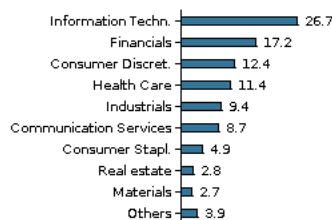

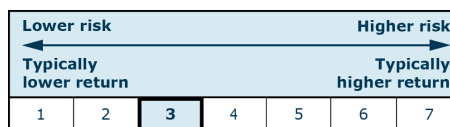
